Minutes: *Minutes from September 2018 Approved. Proposed by Paul Bailey, seconded by George Duncan..*

Dani Robertson S6 student with an interest in Udney history advised of her ambition to present a display of Udney history open to all. Dani was seeking support in this project. Council members indicated support of Dani's project, advising that the Community Trust may be in a position to assist in funding support of the Display with support of the UCC. Members also provided a few contacts where local history may be obtained. Matter was closed with the understanding that Dani would work on the proposed presentation with completed project being submitted on a request for funding.

George Allan George represented a recently formed group engaging Carbon Reduction. Advised of an opportunity for a partially funded 'Fuel Efficient Driving' session for a maximum of 15 attendees. George was seeking support of the UCC in the handling of the outstanding balance due to the provider of the Training program due to the Carbon Reduction group not having banking arrangements setup at present. UCC agreed to be intermediary in the receipt and transfer of the outstanding balance payable to the company providing the training. Colin pursuing required activity.</p>

Paths Project	Letter to be sent by secretary to Steve Baguely with our thanks regarding the opening of new path through the castle grounds. It was noted that there was a lack of information regarding paths in general. Require a map and a means of making public for all to see. Secretary to pursue with Paths group to explore options.
Speed Indicator Signs	<p>Proposed locations for new 'poles' to accommodate speed activated signs to be submitted to the appropriate department of Aberdeenshire council by UCC Secretary. If proposal adopted the intention is for Aberdeenshire council to install the poles at requested locations in readiness for the application of the speed-activated lights.</p> <p>Matt Kaye shall provide map of current Udny boundary enabling the reference points for Pole placements. George shall forward the council contact to the UCC secretary.</p>

AOCB	<p>Strategic Development Plan - Main Issues Report - Wednesday 14th Nov - attended by Colin And Paul. Nothing new presented other than confirmation of SDPA agreement to final content in August 2018 and decision ratified by both Aberdeen City and Aberdeenshire council in September 2018. Representations may be submitted up to midnight of 27th December 2018 for consideration. Conclusions and recommendations to then be presented to the Scottish Government. Next meeting 6th February 2019.</p> <p>Noted that listing of Scotland's Funding Finder to be copied to Rob Henderson. Secretary to action</p> <p>Snow Wardens - Secretary to review previous communication from Council. Establish requirements regarding training. Copy onto council members</p> <p>Colin proposed that a regular meeting of Udny Community Council, Udny Community Trust and Amenities Trust be arranged. Apparent scope for sharing information, supporting projects through shared resource, allowing a true Community approach to issues, short term and long term. Colin to contact each group to establish potential.</p>
