- **AOCB.** Community resilience groups, unable to attend due to date conflict. At February meeting, based on periodic blockage of culverts and flooding of the Bronie it was suggested this should be considered at our next monthly meeting. We were advised of an existing Flood alarm system provided by Aberdeenshire council. This apparently consists of a monitoring system (camera) of culverts in Pitmedden. Should the waters appear to be rising rapidly an alarm is raised by the monitoring station alerting the relevant services. Further Action?
